

## **Information on the Processing of Personal Data**

It is made pursuant to Article 13 of Legislative Decree no. 196/2003 "Code regarding the protection of personal data" (hereinafter only the Privacy Code) to all Visitors and Users, who by logging in and browsing the Borgo il Bonagino Farm Site (hereinafter referred to as "Site") ) at <http://www.borgoilbonagino.it>, expressly and voluntarily communicate their personal and sensitive data to Farmhouse Borgo il Bonagino, which is its owner and manager. The personal data of the Users and Visitors will be treated in compliance with the rules of protection provided by the Privacy Code and other legislation provided for in the matter, specifying that the failure to provide the data indicated as mandatory, will not make it possible to use the site in the part in which it provides for the authorization to process data as a necessary condition for the use of the service and / or navigation and affects the ability to send requests and get a response from the Borgo il Bonagino.

## **Purposes of Data Processing**

The personal data provided through the Site at Farmhouse Borgo il Bonagino: by Customers, Users or Visitors, will be treated in compliance with the Privacy Code, or for purposes such as: *Provide the required services. Provide information and / or offers on events, products, services or initiatives promoted by Farmhouse Borgo il Bonagino or by its partners, a circumstance that may also result in the transfer of data to third parties. In addition, Farmhouse Borgo il Bonagino will be able to: Communicate personal data to people, companies or entities for the detection of the quality of services. Treat data for commercial information and market research, for commercial and promotional purposes, for product or service offers. personal: to individuals, companies or entities that perform banking and financial services; to persons, companies or entities carrying out work or services of any kind in the context of contractual services as well as services for collections, payments, management effects, checks and other securities (Attention: for the purposes of payment of services by credit card the communication of data takes place automatically by the User's choice). Perform market surveys and marketing studies. Collaboration with the competent judicial authorities for purposes related to the prevention and repression of crimes. For any other need and necessity connected to the nature and activities of the Farmhouse Borgo il Bonagino.*

In any case, the processing of data and any other information concerning the Users of the Site and / or the Clients of the Farmhouse Borgo il Bonagino that navigate us will be used in compliance with the principles of correctness, transparency, lawfulness and protection. ## **Owner, Manager and Methods of Data Processing**

The "Owner" of the processing of personal data is the Agriturismo il Bonagino, located in Radda in Chianti (SI), Loc. Bonagino, S.P. 2 / Bis, in the person of the legal representative p.t., who is the manager, and the place of treatment and care of the same is at the premises of the farmhouse.

## **Rights of the interested parties pursuant to the Privacy Code**

The persons to whom the personal data communicated and / or eventually collected, have the right at any time to obtain information about the existence or otherwise of the data and to know its content and origin, verify its accuracy or request the integration, modification and / or updating and also the cancellation, or to oppose in any case, for legitimate reasons, to their treatment. For this purpose and for every good account and protection of the Users of the Site, the content of the art. 7 of Legislative Decree. 196/2003 (Right of access to personal data and other rights) of the Privacy Code: "1. The interested party has the right to obtain confirmation of the existence or non-existence of personal data concerning him / her, even if not yet registered, and their communication in intelligible form 2. The interested party has the right to obtain the indication: a) of the origin of personal data, b) of the purposes and methods of the processing, c) of the logic applied in case of treatment carried out with the electronic tools, d) of the identifying details of the data controller, of the data processors and of the designated representative according to article 5, paragraph 2, e) of the subjects or categories of subjects to whom the personal data may be communicated or who may get to know them as appointed representative in the territory of the State, managers or agents 3. The interested party has the right to obtain: a) updating, rectification or, when interested, integration of data; b) the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed; c) the attestation that the operations referred to in letters a) and b) have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except in the case where this fulfillment is it proves impossible or involves a use of means manifestly disproportionate to the protected right. 4. The data subject has the right to object, in whole or in part: a) for legitimate reasons, to the processing of personal data concerning him / her, even though they are relevant to the purpose of the collection; b) to the processing of personal data concerning him / her for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
